WHEREAS the SETTLORS No. 2 Sri Ram Avtar Jasrasaria Settlor No. 8 - Mrs. Veena Jasrasaria and Settlor No. 9 - Mrs. Puspa Jasrasaria ~~xxxx~~ who are also the Trustee Nos. 11, 17 and 18 respectively of the above named have empowered and authorised Settlor as well as Trustee namely Sri Anup Kumar Jasrasaria to sign and execute this Deed of Trust in their names and on their behalf vide General Power of Attorney bearing Regn. No. 2889 dtd. 25-7-2008 duly executed and registered at the office of the Sr. Sub-Registrar, Kamrup, Gauhati and as such Sri Anup Kumar Jasrasaria signed and executed this Deed of Trust for himself as well as for and on behalf of the abovenamed Settlers and Trustees.

WHEREAS the SETTLORS are desirous of creating a Trust for Public Charitable purposes and in order to effectuate the said desire they have handed over a sum of Rs. 5100/- (Rupees Five thousand one hundred) only each aggregating Rs. 45900/- (Rupees Forty five thousand nine hundred) in cash to the Trustees by way of their initial contribution.

AND WHEREAS the TRUSTEES have at the request of the said settlors agreed to act as Trustees and to have to hold the said sum of Rs. 45900/- (Rupees forty five thousand nine hundred) only together with all accretions thereto and all properties that may be acquired out of the same or otherwise (hereinafter referred to as the "TRUST FUND") for the objects and purposes mentioned in these Trustees and the Settlers do hereby relinquish and release for all time to come all their right, title and interest they had over the said sum of money which from to-day vest in the aforesaid Trustees and the Trust has become full and absolute owner of the said sum.

NOW THIS INDENTURE WITNESSETH AS FOLLOWS :

1. NAME: The name of the Trust shall be SARVA SHIKSHA EDUCATIONAL FOUNDATION.
2. OFFICE : The head office of the Trust shall be at Chotahapjan in the District of Tinsukia (Assam) with such branch or branches at such place or places as the Trustees may decide.
3. OBJECTS: The objects for which the Trust is created shall be generally the relief to poor, education, medical relief and the advancement of any other object of general public utility and for such purposes:-
 - (i) To open, found, establish, promote, set up, run maintain, assist, finance, support and/or aid or help in the setting up and/or maintaining and/or running Universities/Schools, colleges, lecture halls, libraries, reading rooms, boarding houses, museums, research institutions, yoga camps, training and vocational institutions and other establishments or institutions for the development of education and diffusion of knowledge in the field of arts, science, commerce, literature, humanities and other subjects in all their manifestations;
 - (ii) To open, found, establish, promote, set up, maintain, assist, finance, support and/or aid or help in the setting up and/or maintaining and/or running hospitals, nursing homes, charitable dispensaries, maternity homes, Ayurvedic/Homoeopathic Aushadhalayas, child welfare centers, clinic, convalescent homes, sanitarium hospital and other similar institutions or centers for rendering or providing medical relief and/or aid to the people;
 - (iii) To grant pay or give scholarship, stipends, prizes, rewards, allowances and other financial assistance or help in cash or kind to students with a view to help them in prosecuting their studies, research etc;
 - (iv) To encourage exchange of views and interaction amongst professionals in various fields such as arts, science, commerce as well as students and general public about latest developments and research work in various fields by organizing seminars, conferences, meetings, get-togethers, refresher courses by using different mediums of mass communications and to publish books, pamphlets, periodicals, news letters, magazines etc. for the aforesaid purposes.

- (v) To open, found, build, restore, establish, promote, set up, run, maintain, assist, finance, support and/or aid or help in the setting up and for maintaining and/or running community-centers, Dharmshalas, Bhawanas, auditoriums, guest houses, wells, deep tube-wells, tanks, roads, play grounds, parks, gymnasiums, bathing ghats for the use of general public and for promotion of social welfare work;
- (vi) To grant relief during natural and other calamities such as flood, fire, famine cyclone, earthquake, storm, accident, pestilence, draught, epidemic etc. and to give donations, subscriptions or contributions to institutions, establishments, centers, organizations or persons doing such relief work;
- (vii) To open, found, establish, promote, set up, run, maintain, assist, finance, support and/or aid to or help in the setting up and/or maintaining and/or running orphanages, widow homes, old age homes, lunatic asylums, poor houses or other establishments for relief and/or help to the poor, old, infirm, widows and destitutes;
- (viii) To undertake any programme or programmes of rural, semi-urban and urban development including any programme for promotion of the social and economic welfare of or upliftment of the public in above areas;
- (ix) To render assistance and/or grant aid to recognized public charitable trusts or institutions;
- (x) To undertake any other charitable work for the benefit of general public as the trustees may in their sole discretion think fit.
- (xi) To do all such things and undertake such activities as may appear to the trustees in their discretion as incidental or essential for carrying out any one or more of the objects of the trust.
4. **BENEFICIARIES:** The trust shall be a public charitable trust and the beneficiaries of this Trust shall be public in general without distinction of any religion, caste, colour or creed.

BOARD OF TRUSTEES, THEIR APPOINTMENT AND POWERS, ITS MEETINGS ETC.

5. BOARD OF TRUSTEES:

- (a) The affairs of the Trust shall be managed, controlled and supervised by the Board of Trustees.
- (b) The maximum number of Trustees shall be 15 (Fifteen) and the minimum number of trustees shall be 9 (nine) The number of trustees may be increased by a resolution passed by Trustees in their meeting.


- (c) The Settlers herein shall be trustees of this trust during their life time.
- (d) The Trustees from amongst themselves may elect the following office bearers :-
 - (1) Chairman-cum-Managing Trustee

6. MEETING OF THE BOARD OF TRUSTEES:

- (a) The trustees shall hold meetings of the Board of Trustees from time to time as may be necessary.
- (b) At least one meeting of the Board of Trustees be held once in every three months.
- (c) The Chairman-cum-Managing Trustee may himself/ herself or he/she may direct the Secretary to convene the meeting of the Board of Trustees. Any Trustee may request the Chairman-cum-Managing Trustee to convene the meeting by a requisition in writing and specifying the objects for which he/she wants the meeting to be convened. If the Chairman-cum-Managing Trustee does not hold the meeting within one month of the requisition, the Trustees sending the requisition may convene the meeting at the office of the Trust but no business other than that specified in the requisition will be transacted at such meeting.
- (d) Notice of all meetings of the Board of Trustees will be sent to the permanent address or the previously intimated address of the Trustees.
- (e) The quorum of the meeting shall be 1/3rd (one third) of the total number of Trustees for the time being or 3(three), which ever is higher. But there will be no quorum for the meeting adjourned for want of quorum. While computing the quorum, fraction thereof shall be ignored.
- (f) The Chairman-cum-Managing Trustee shall preside over all the meetings of the Board of Trustees. If in any meeting the Chairman-cum-Managing Trustee is not present within 30(thirty) minutes of the time appointed for the meeting, then the vice chairman and in his absence any one of the Trustees, as may be decided by the Trustees present shall preside over such meeting.
- (g) Minutes of every meeting of the Board of Trustees shall be prepared and placed for confirmation of the next meeting and if confirmed, shall be signed by the Chairman of the meeting.

- (h) All decisions of the Board of Trustees shall be by majority of votes and in the case of equality of votes the Chairman of the meeting shall have the second or casting vote.
- (i) A meeting of the trustees for the time being at which a quorum is present shall become competent to exercise all or any of the authorities powers and discretions by or under this deed vested in them or otherwise exercised by them.
- (j) The Trustees may from time to time frame rules for the conduct and regulation of the meetings of the Board of Trustees.

7. POWERS, DUTIES ETC. OF THE BOARD OF TRUSTEES

The Board of Trustees shall have all powers appropriate and necessary for the fulfilment of any or all of the objects of the Trust or necessary and appropriate for the effective and efficient administration of the Trust properties and affairs. Without affecting the generality of such powers and functions, the Board of Trustees shall have the following powers and perform the following functions;

- (i) To accept donations, contributions, grants, subscriptions or any aid or assistance or help in cash or in kind from any person, persons, firms, companies, trusts, body or bodies corporate etc.;
- (ii) To apply the whole or any part of the income or accumulation thereof or the whole or any part of the corpus or the trust property or fund for one or more of the objects of the Trust as the Board of Trustees may determine from time to time;
- (iii) To invest and keep invested the Trust fund in immovable properties, movable properties, shares, stocks, debentures or in other securities etc. strictly in conformity with the provisions of the Income Tax Act, 1961, or same other law for the time being enforce and to alter, vary or transpose such investments from time to time as the Trustees may in their discretion think fit.
- (iv) To sell, dispose of, alienate or otherwise deal with any property, movable or immovable, comprising the Trust fund;
- (v) To let out or demise any immovable property comprised in the Trust fund for the time being on such rent and on such other terms and conditions as the Board of Trustees shall think fit and proper for the benefit of the Trust;
- (vi) To borrow if need be against the security of the assets of the Trust by way of bank overdraft, loan or otherwise as may be necessary, for the benefit of the Trust and to more effectively carrying out the objects of the Trust.


- (vii) To open account or accounts with any Bank or Banks, to operate such account or accounts and to give instructions to the bank or banks and to provide for opening and operation of such account(s) by one or more of the Trustees or by any other person or persons and agent appointed by the Trustees as the Trustees may think fit.
- (viii) To adjust, settle, compromise, compound, commence, abandon refer to arbitration, all actions, suits, claims, demands, disputes, difference and proceedings regarding the properties and affairs of the Trust;
- (ix) To appoint constituted attorneys, agents, munims, accountants, secretary, auditors or other servants, to delegate to such attorneys or agents or servants, all or any of the powers vested in the Trustees under these presents and from time to time remove such attorneys or agents or servants etc. and to appoint another or others in their place and the fix their duties, responsibilities and the terms and conditions of their appointment;
- (x) To appoint or make provision for the appointment of committees or sub-committees of trustees and or others to attend to or supervise or conduct such job or functions or trust matters in such rules and regulations as the Trustees may prescribe;
- (xi) To make, alter, amend or modify or repeal rules and regulations, bye-laws, for carrying out the objects of the Trust and for the management of the affairs of the Trust and for running of institutions in furtherance of the objects of the Trust and/or giving effect to the objects of the Trust;
- (xii) To set apart the whole or part of the income or corpus of the Trust for any of the objects of the Trust;
- (xiii) The Trustees shall not be entitled to receive any remuneration as Trustees but may reimburse themselves of expenses actually incurred by them in connection with the work of the Trust or their duties relating thereto;
- (xiv) The Trustees shall be chargeable only for such moneys, stocks, funds, securities and income and/or any other trust property as shall actually come into their hands and a Trustees shall not be answerable or accountable for neglect, default, acts of omission or commission of the other Trustees nor of any other person with whom the Trust properties or securities may have been deposited or kept;

- (xv) If any Trustee dies, retires, or becomes unfit or incapable to act, continuing or surviving Trustees will be competent to appoint a Trustee in place of such Trustee.

8. REMOVAL AND RETIREMENT OF TRUSTEES:

- (a) Any Trustee may retire from office upon giving one month's notice in writing to the remaining Trustees or to the Managing Trustee of his/her intention to do so and such resignation/retirement shall take effect upon expiration of such notice or its earlier acceptance;
- (b) A Trustee shall cease to be a Trustee :
- If he/she dies;
 - If he/she becomes insane;
 - If he/she resigns;
 - If he/she is convicted of any offence involving moral turpitude.

9. A Trustee may be removed by the Board of Trustees if it considers that the activities of such Trustee are detrimental to the interest of the Trust, Provided, however, no trustee can be removed under this provision unless;

- Such Trustee is apprised of precise charges against him/her and is given proper opportunity to explain his/her case;
- The resolution removing his/her is passed at least by 3/4th (three fourth) majority of the Trustees present in that meeting.


10. ACCOUNTS:

- (a) A true and correct account shall be kept for all moneys received spent as well as of all the assets, credits and effects of Trust properties and/or all matter in respect thereof in course of the management of trust properties or in relation to carrying out of the object of the Trust. such accounts shall be got audited by a Chartered accountant.
- (b) The accounting year of the Trust shall be such as the Trustee may decide.


11. A resolution in writing circulated amongst all the Trustees for the time being and signed affirmatively by majority of the Trustees shall be as valid and effective as if it has been passed at a meeting of the Board of Trustees duly called and convened.

12. The Board of Trustees may from time to time frame rules and/or amend, modify, add to and delete such rules for the conduct of affairs of the Trust and also for regulating the meeting of the Board of Trustees in accordance with the provisions of the presents. Contd. ---p/11
